**A MANUAL TO ASSIST THE PUBLIC HIGHER EDUCATION INSTITUTIONS
OF NORTH CAROLINA IN THE MATTER OF
STUDENT RESIDENCE CLASSIFICATION FOR TUITION PURPOSES**

[The policies of the University of North Carolina to assist the constituent institutions in classifying students by residence for tuition purposes are set forth in a residence manual. This manual was last amended by the Board of Governors in September 1985, and is currently undergoing revision.]

POLICIES AND PROCEDURES OF THE STATE RESIDENCE COMMITTEE

The Board of Governors delegated to the president the responsibility for the conduct of appeals beyond the constituent institutions with respect to denial of petitions for resident status for tuition purposes. The president, in conjunction with the North Carolina Department of Community Colleges, in turn, established a State Residence Committee to resolve residentiary claims by students of misclassification. The State Residence Committee has established rules for the conduct of its business. The current document for that purpose is the "Policies and Procedures of the State Residence Committee," as amended November 8, 1995. Copies may be obtained at UNC General Administration.

Catalog Statement on Residence Classification for Purposes of Applicable Tuition

The State Residence Committee suggests that all institutions include in their catalogs the following two points about residence classification:

1. "To qualify for in-state tuition a legal resident must have maintained his or her domicile in North Carolina for at least the 12 months immediately prior to his or her classification as a resident for tuition purposes. In order to be eligible for such classification, the individual must establish that his or her presence in the state during such twelve-month period was for purposes of maintaining a bona fide domicile rather than for purposes of mere temporary residence incident to enrollment in an institution of higher education; further, (1) if the parents (or court-appointed legal guardian) of the individual seeking resident classification are (is) bona fide domiciliaries of this state, this fact shall be prima facie evidence of domiciliary status on the individual applicant and (2) if such parents or guardian are not bona fide domiciliaries of this state, this fact shall be prima facie evidence of non-domiciliary status of the individual."
2. "University regulations concerning the classification of students by residence, for purposes of applicable tuition differentials, are set forth in detail in *A Manual to Assist the Public Higher Education Institutions of North Carolina in the Matter of Student Residence Classification for Tuition Purposes*. Each enrolled student is responsible for knowing the contents of that *Manual*, which is the controlling administrative statement of policy on this subject.
